

Rosebud Plaza Spend, Spin to Win August 2025

- 1. Information on how to enter and gifts(s) form part of these Terms and Conditions.
- 2. Participation in the **Spend, Spin to Win Promotion** is deemed acceptance of these Terms and Conditions.
- 3. The promotion will commence at 10am on Wednesday 20th August 2025 and closes at 2pm on Thursday 21st August or while stocks last (Promotional Period).
- 4. Claimants must be aged over 18 years old.
- 5. Employees and immediate families of the Promoter and their associated companies and agencies, Rosebud Plaza retailers and their employees are ineligible to claim.
- 6. There is a limit of one (1) claim per eligible claimant permitted per day during the Promotional Period.
- 7. The Promoter reserves the right to cancel the Promotion at any time. Should the Promoter cancel the Promotion the Promoter will: advertise that the Promotion has been cancelled by placing a notice at Rosebud Plaza website and social channels; the personal information you have provided on the entry form will not be used in any manner whatsoever.

ELIGIBILITY

- 8. An "Eligible Transaction" is a purchase from a Participating Store made during the Promotion Period: (a) of any goods or services, but these must not be:
 - (i) Tobacco Products; or
 - (ii) Gaming Products; or
 - (iii) Gift Cards; or
 - (iv) Goods purchased pursuant to a prescription; or
 - (v) Deposits into banks, building societies or other financial institutions or payments on account of insurances and the like; or
 - (vi) Telephone, internet or mobile phone calling cards or credit cards; or
 - (vii) Payments for registrations (e.g. motor vehicle registration), payments for services (e.g. electricity, gas, telephone), premiums (e.g. insurance and health fund premiums), rates and subscriptions.
 - (viii) Products that have been returned for a refund.
- 9. A purchase of an item on lay-by will be deemed to be an Eligible Transaction only upon completion of the lay-by, if the purchase otherwise would qualify as an Eligible Transaction. To remove any doubt, the final lay-by instalment payment must be made during the Promotion Period.

- 11. A "Specialty Store" is a participating store that is not a Major Store.
