

**Rosebud Plaza
Winter Shop & Win Promotion

1. The promoter is Rosebud Plaza ("Promoter").
2. Information on how to enter and prize(s) form part of these Terms and Conditions.
3. Participation in the **Winter Shop & Win Promotion** is deemed acceptance of these Terms and Conditions.
4. The competition will commence at 9am on Monday 03 August 2026 and closes at 5pm on Sunday 30th August 2026.
5. Entry is open to residents of Victoria; Australia aged over 18 years and over. Employees of the Promoter, Rosebud Plaza retailers, associated agencies and their immediate families are ineligible to enter.
6. The Promoter reserves the right to cancel the Promotion at any time. Should the Promoter cancel the Promotion the Promoter will: advertise that the Promotion has been cancelled by placing a notice at Rosebud Plaza website and social channels; the personal information you have provided on the entry form will not be used in any manner whatsoever.

7. How to Enter

To enter the promotion, customers must during the Promotion Period:

- Spend \$50 or more at any participating retailer/s at Rosebud Plaza (combined receipts are accepted);

- Complete the official online entry form with all required details; and
- Upload a valid proof of purchase/receipt at the time of entry.

Entries submitted without a valid proof of purchase upload may be deemed invalid.

Participants may enter multiple times; however, each entry must be linked to a separate qualifying transaction and receipt.

8. Proof of Purchase Requirements

Proof of purchase must clearly show:

- The retailer/s name;
- Date of purchase;
- Transaction amount; and
- Proof that the transaction occurred during the Promotion Period.

The Promoter reserves the right to request the original receipt for verification purposes.

9. Excluded Purchases

The following purchases are excluded from the Promotion and are not eligible to be used as qualifying transactions:

- Alcohol purchases;

- Bill payments, bank transfers, and financial services transactions;

- Australia Post services including postage and parcel collections;

- Refunds, exchanges, or cancelled transactions; and
- Any purchase prohibited by law.

The Promoter reserves the right to determine the eligibility of all transactions and may request further information or proof of purchase for verification purposes.
